As a part of this agreement to use the Facility and participate in "KOA Jr Archery Day", you agree to indemnify and hold-harmless Seven Mountains Media, KOA, event sponsors and volunteers for any injuries sustained by you, your guest, guest's children, invitees, or other persons.
